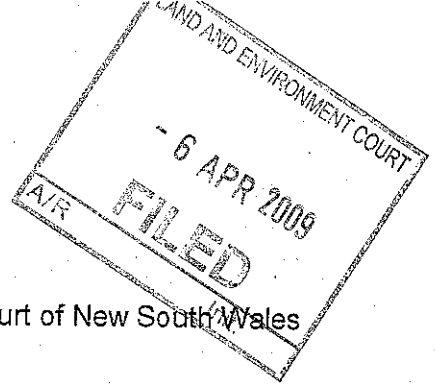

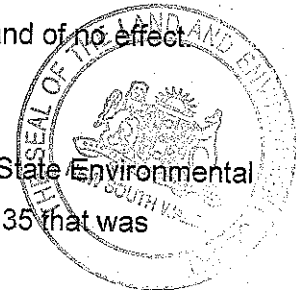

TYPE OF CLAIM

Planning Law – Other judicial review

RELIEF CLAIMED

- 1 In relation to the decision by the first respondent to grant concept plan approval MPA 07_0064 for the development of the Huntlee New Town on 9 February 2009 under section 75O of the Environmental and Assessment Act 1979 ("the Act"):
 - a. a declaration that the said concept plan approval is void and of no effect.
 - b. an order quashing the said concept plan approval.
- 2 In relation to the decision by the first respondent to amend the State Environmental Planning Policy (Major Projects) 2005 through Amendment no. 35 that was gazetted on 9th January 2009:
 - a. a declaration that the gazettal of Amendment no.35 is void and of no effect.
 - b. an order quashing the said gazettal.
4. An order that the respondent pay the applicant's costs of the proceedings.
5. Such further or other orders as the Court thinks fit.
