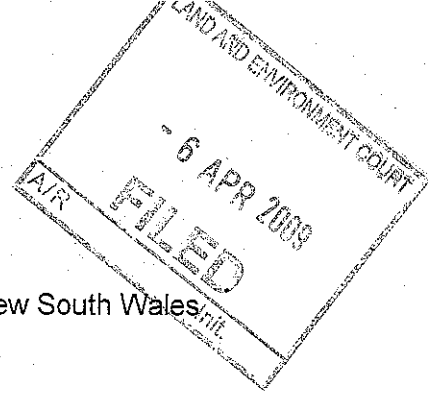

You must enter an appearance before you can appear before the court.

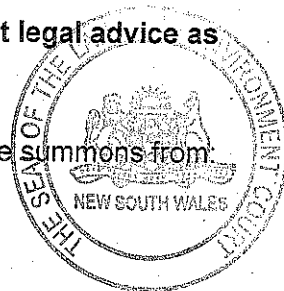

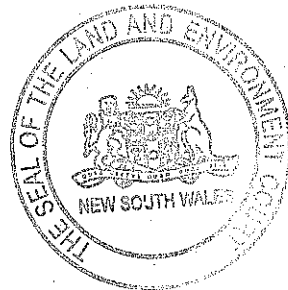
