What legal problems can EDO help with?

Depending on what your legal problem is, EDO might give you legal advice or information, or we might represent you and take legal action on your behalf. This can include going to court.

We **can** help you with lots of different areas of law, including:

- Cultural Heritage
- Major development and infrastructure
- Mining, fracking and energy (including off-shore oil and gas)
- Logging and other vegetation clearing
- Pollution and waste
- Access, use and protection of water including rivers and oceans
- Access to information about government decisions impacting your Country
- Corporate and government conduct

- Private disputes

How do we work?

EDO is a national organisation, with offices across Australia. We also have a dedicated specialist First Nations and Country and Cultural Heritage team. This team provides advice to and represents First Nations clients, communities and organisations. If EDO can't help with the area of law you are asking about, we will try to find you another lawyer who can.

EDO recognises the unceded sovereignty of First Nations people and their inherent right to self-determination and control of their lands and waters. We also respect the collective nature of First Nations rights and interests in Country and Cultural Heritage and the principle of Free, Prior and Informed Consent. We provide culturally safe services and will securely protect any Indigenous Cultural Intellectual Property (ICIP) that you chose to provide when dealing with us.

Examples of how EDO can help First Nations clients, communities & organisations to protect Country and Cultural Heritage:

- provide advice about water frameworks, plans and allocations
 - prepare applications to protect Cultural Heritage under the Federal *Aboriginal and Torres Strait Islander Heritage Protection Act 1984*
 - run court challenges about government decisions impacting on Country (including water) and/or Cultural Heritage
 - draft submissions under Federal or State environmental approval processes
 - draft submissions to government about proposed changes to laws and policies about Cultural Heritage and environmental laws

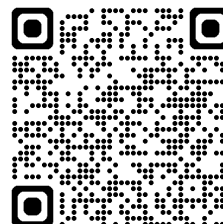
